



This is a list of the layers which you can choose to add to Te Kete Kōrero a Te Takutai Moana Information Hub (Kōrero Takutai) using the 'Add data' window. Each layer is briefly described below. The information includes the organisation that created the layer, and the source of the data. You can add layers by searching for the full layer name or one of the search tags listed. Many of these layers will also have 'sub-layers' which will be added to the map. Sub-layers can be turned on or off in the layer list window, in the same way that normal layers can.

Hint: if you are looking for data in a specific area, try searching for the relevant regional council. This will bring up results for every layer that has information in that region.

To see any further details about each of these layers, click on the details button next to the layer in the 'Add data' window. The year or date stated in the heading of the layer indicates the year in which the data was obtained. If no date is stated, the layer is real-time data.
