Financial assistance scheme review & draft Crown engagement strategy

Thank you to everyone who provided feedback on the financial assistance scheme review (the scheme) and the draft Crown engagement strategy (the strategy). Amongst other things, you told us the scheme needs to reflect true applicant costs in the High Court, Crown engagement applicants need to receive funding earlier, and reimbursements should be faster. On the strategy, you told us the timeframes for engagement are too long and you wanted to know more about how the proposed coastlines were chosen.

We are working through all the feedback you gave us and what it means for the review of the scheme and the draft strategy. In the new year we will report to Ministers, including options for change.

Funding changes

While the financial assistance scheme review is underway, we have been able to make some changes. We have updated the funding guidelines to make them easier to navigate, we've provided two template forms for you to use if you would like to move funding between or within milestones, we've lowered the threshold for reimbursement requests from \$3,000 to \$1,000, and we've adjusted the funding matrices for inflation. Korero Takutai

High Court & Waitangi Tribunal

There are two High Court hearings scheduled for next year: *Taylor (Ngāti Pāhauwera)* in Napier, February 2021; and *Reeder (Ngā Pōtiki)* in Tauranga, April 2021 (stage one) and September 2021 (stage two). For minutes and judgments of the High Court, visit their website here.
